A customs declaration is an official document that gives details of goods that are being imported or exported into or out of EU customs territory. It is the legal act whereby an operator indicates their intention to place those goods under an EU customs procedure, as described in the Union customs. The Customs Declaration Service supports making import and export declarations when moving goods into and out of the UK. You'll need to use the UK Trade Tariff to help complete your import or export declaration. To make an import declaration you need to choose how to pay duties, VAT or excise.
